- I authorize the National Pardon Centre to act on my behalf for the purpose of obtaining, for me, a Canadian pardon, from the National Parole Board, purge and/or file destruction from the arresting police service(s)/RCMP, and/or for the purpose of obtaining, for me, a USA Entry Waiver from the Department of Homeland Security.
- I give permission for the National Pardon Centre to communicate with all government offices necessary for the completion of my file, including but not limited to the RCMP, local police, courts, Department of Homeland Security, Parole Board of Canada and any additional office/agency necessary for the completion of my file.
- I understand that further criminal activity/police involvement occurring while my Canadian pardon and/or US Entry Waiver is in process will result in a significant postponement on my eligibility, and I further understand that any delay caused by my own activity will result in further charges to be covered by me.
- I understand the price structure of the services provided by the National Pardon Centre are for the preparation of applications only and do not include the respective government fees, and that the National Pardon Centre has no authorization whatsoever in granting or refusing Canadian pardons, purges, file destructions or USA Entry Waivers. Decisions rest solely with the appropriate government bodies, as do the processing timeframes.
- I understand that the initial file activation fee of \$200 is non-refundable. Furthermore, no refund will be provided after 30 days or in cases where pardon, waiver and/or fingerprinting procedures have been initiated or completed.
